RESEARCH INTERESTS

Neuroethics of Enhancement. I have very recently become interested in the issues surrounding the enhancement of various psychological and physical characteristics in healthy adults. The nonmedical use of drugs is becoming a very important and debated topic in the field of neuroethics. I am interested in examining the types of characteristics that healthy people would or would not enhance, and their reasons for these decisions. For example, why might a healthy person take a drug to enhance their memory but not their mood? I am also interested in examining the correlates of such views. For example, what are some of the personality variables that might be associated with one's willingness to use drugs nonmedically. I have begun to address these questions by using a combined approach of focus groups and larger-scale surveys in university students. I am also planning to develop a scale to measure attitudes toward nonmedical enhancement.

Mild Cognitive Impairment and Dementia. With respect to the early identification of dementia, I have chosen to focus much of my research on individuals who are Cognitively-Impaired-Not-Demented (CIND), a form of mild cognitive impairment. Individuals diagnosed as CIND are important to study because they demonstrate a greater than normal risk for developing dementia. However, not all CIND individuals develop dementia. Accordingly, it has been difficult for clinicians and researchers to prospectively identify which CIND individuals will and will not convert to dementia. My research has shown that CIND is a very cognitively heterogeneous condition and that neuropsychiatric symptoms are common in this population. More recently, I have started to take a more critical perspective on definitions of mild cognitive impairment (MCI). My colleagues, Drs. Stephen Katz and Peri Ballantyne, and I have received funding from CIHR to investigate the 'perceptions and realities' of MCI. I am particularly interested in examining how we should be defining effectiveness in intervention studies. What is the best way to measure whether a drug or intervention is producing a statistically and clinically meaningful benefit? I am also interested in how the public perceives issues related to the diagnosis and treatment of MCI and Alzheimer disease (AD). How does the public define effectiveness as it relates to treatment, and how do these definitions compare to the actual effectiveness of currently available drugs?

The Role of Sleep in Memory. A considerable amount of research has shown that sleep has a beneficial role in the consolidation of certain kinds of memory. There is currently debate about which sleep state (e.g., rapid eye movement versus slow wave sleep) is involved in memory and about which kinds of memory (e.g., implicit versus explicit memory) are benefited by sleep. Concerning sleep and memory, I have three main areas of interest. First, with funding support from NSERC, I have been investigating whether rapid eye movement sleep or slow wave sleep has a beneficial role in emotional memory using comparable implicit and explicit memory tasks. Second, I am interested in how sleep is involved in facilitating motor learning. Third, I am collaborating with one of my colleagues – Dr. Carlyle Smith – to examine whether age-related changes in sleep architecture might be related to age-related changes in cognition. Our collaborative work in this area has been funded by the Canadian Institutes of Health Research (CIHR) and the Alzheimer Society of Canada. I am also part of the Centre for Biological Timing and Cognition, which involves Trent University, the University of Toronto, Lakehead University, and Toronto Hospital Western Division. Researchers from each of these universities were successful in obtaining a grant from the Canadian Foundation for Innovation and Ontario Innovation Fund. Although I am not one of the principal investigators, I am listed on this grant as a collaborator.
